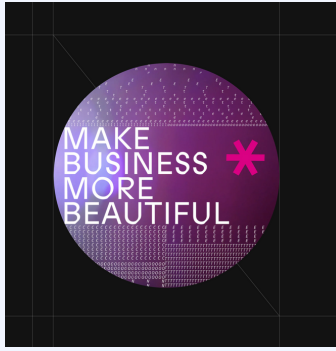
Retirement Planning

There are eight bills before congress regarding retirement planning and benefits. While nothing has passed yet, some areas under consideration are, among other things, boosting the required minimum distribution age, expanding auto-enrollment in retirement plans and allowing penalty-free withdrawals from 401(k)s. This will impact our employer sponsored programs. Get ready.



ACA Requirements for Small Employers

The IRS has proposed two significant changes to electronic filing requirements for various information returns including not just the Forms 1094-C and 1095-C filings required of many employers by the Affordable Care Act (ACA), but common payee statements like Forms W-2 and 1099. All but the very smallest employers will be required to file these forms electronically for filing due dates falling in 2022 and beyond. ACA services as well as payroll providers should be able to provide these services, but they may be challenged by the additional volume. Plan accordingly!
